

**OPEN CLASS PHOTOGRAPHY DEPARTMENT

RULES**

1. **See Open Class General Rules.**
2. Only one exhibit per entry number.
3. Exhibits will be accepted between 2:00 p.m. and 8:00 p.m. Tuesday in the Arena. No exhibits will be accepted after 8:00 p.m. Tuesday. Exhibits must be in place until 7:15 p.m. on Sunday. Exhibitors must have their claim checks to pick up exhibits.
4. Judging will begin at 9:00 a.m. Wednesday.
5. Only exhibitors that are non-professional artists are eligible to enter. (Non-professional is defined as any person whose income from the sale of art work is less than ½ of their total personal income.)
6. Entries must be original works of the exhibitor and must have been photographed since the previous Waukesha County Fair date. Once a photo has been entered into the Waukesha County Fair it cannot be entered again. Same image should not be entered as a vertical in one category and as a horizontal in another category.
7. All photos other than those entered in **Photography Framed & Matted by Exhibitor** must be mounted on a single sturdy piece of white or black poster board only, with good photographic adhesive, such as rubber cement, dry mount or permanent scrapbooking tape (glue stick is not recommended). All photos 5" x 7" or smaller should be mounted on a 7" x 11" poster board. All photos larger than 5" x 7" should be mounted on a 11" x 14" poster board. On the back side of the poster board indicate the top of the photo for hanging purposes. Other mounting board/mat board, materials or colors will not be accepted. No foam board. Holes will be punched by the Superintendents in order to hang.
8. Photographs entered in **Framed & Matted by Exhibitor** MUST be securely and rigidly framed by the Exhibitor and suitably wired for hanging using metal clips or screw eyes and picture wire and be no larger than 36" x 36" or they may be rejected.
9. All articles are exhibited at the owner's risk. The Fair Management assumes no responsibility for losses. Entries should be removed promptly at 7:15 pm on Sunday. The Waukesha County Fair Assn., Inc. will take every precaution for their safekeeping, but will not be held responsible for any damage or accident that may occur.
10. Nudes or nude figure study models not allowed..
11. No captions or dates on photos or poster board.
12. Staple Entry Tag on the lower right hand corner as close to the frame or poster board as possible.
13. All entries can be either Film or Digital.
14. Photos that have been digitally altered beyond standard optimization (cropping, reasonable adjustments to exposure, color and contrast, etc.) must be entered in the Special Effects or Digital Manipulation classes.
